### **APPLICATION OF CHRISTOPHER DENTZEL, AGENT FOR STEPHEN AND MAJA GREIG, 407 CONEJO ROAD, APN 019-050-009, A-1 ONE-FAMILY RESIDENCE ZONE, GENERAL PLAN DESIGNATION: MAJOR HILLSIDE (MST2009-00423)**

The 20,149 square foot project site has frontage on Conejo Road and Stanwood Drive. The previous development on site consisted of a single-family residence and attached two-car garage, which were destroyed in the Tea Fire. The project consists of construction of a new 2,519 square foot, two-story single family residence, an attached 454 square foot two-car garage and a new retaining wall. The discretionary application required for the project is a Modification to permit new construction within the required 35' front setback off of Conejo Lane (SBMC §28.15.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15303 and 15305.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. Written comments are also welcome up to the time of the hearing, and should be addressed to the Staff Hearing Officer Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990. This is the only notification you will receive for this development application. The scope of this project may be modified under further review. If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
