APPLICATION OF SURE SITE CONSULTING GROUP LLC, AGENT FOR PB MICHELTORENA LLC, 525 E. MICHELTORENA STREET, APN 027-260-031, C-O MEDICAL OFFICE ZONE, GENERAL PLAN DESIGNATION: MAJOR PUBLIC & INSTITUTIONAL (MST2010-00049)

The proposed project involves the construction of two faux chimneys on the roof of an existing three-story commercial building. The chimneys will house panel antennas for a T-Mobile installation. An existing wireless facility for Sprint that utilizes two existing faux chimneys will remain. The discretionary application required for the project is a Modification to permit one of the two new chimneys to be located within the required 15' front setback (SBMC §28.51.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15303 & 15305.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
