The 8,319 square foot project site is currently developed with a two story residence and attached two-car garage. The proposed project involves enclosing an existing 104 square foot upper level balcony at the rear of the residence, and the addition of a 20 square foot storage closet on the patio below. The discretionary application required for this project is a Modification to permit new floor area within the required six-foot interior setback (SBMC §28.15.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15301 & 15305.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
