### **APPLICATION OF RAIN & DANA LONGO, AGENT FOR HLINKA TRUST, 4119 SAN MARTIN WAY, APN 059-212-037, R-2 TWO-FAMILY RESIDENCE/SD-2 SPECIAL DISTRICT OVERLAY ZONES, GENERAL PLAN DESIGNATION: 12 UNITS PER ACRE (MST2010-00272)**

The 5,914 square foot vacant project site is located on the corner of San Martin Way and Verano Drive. Proposed development is for a two-story, 1,912 square foot single-family modular residence with an attached, two-car, 400 square foot garage. The discretionary applications required for this project are Modifications to allow less than the minimum dimension for the required open yard area and to provide a portion of the open yard in the front setback and front yard (SBMC §28.18.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15303 & 15305.

The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
