### **APPLICATION OF DOUGLAS KEEP, ARCHITECT FOR MICHAEL AND KRISTEN DESMOND, 215 E. VALERIO STREET, APN 027-112-013, R-2 TWO-FAMILY RESIDENCE ZONE, GENERAL PLAN DESIGNATION: 12 UNITS PER ACRE (MST2010-00377)**

The 10,071 square foot project site is currently developed with a single family residence and a detached two-car garage with accessory space. The proposed project involves a 287 square foot addition to the residence, new fencing, new trellis, and minor exterior alterations including the replacement of garage doors, replacement of a window with a door at the garage, removal of five Palm trees from the backyard, and new paving material for a portion of the driveway. The discretionary application required for this project is a Modification of the location and dimensions of the required open yard area (SBMC §28.18.060.C).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Sections 15301 (Existing Facilities) & 15305 (Minor Alterations in Land Use Limitations).

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. Written comments are also welcome up to the time of the hearing, and should be addressed to the Staff Hearing Officer Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990. This is the only notification you will receive for this development application. The scope of this project may be modified under further review. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
