APPLICATION OF TOM OCHSNER, ARCHITECT FOR ROY PETERSON, 652 RICARDO AVENUE, APN 035-170-025, E-1 ONE-FAMILY RESIDENCE ZONE, GENERAL PLAN DESIGNATION: HILLSIDE RESIDENTIAL (MAXIMUM 3 UNITS/ACRE) (MST2011-00368)

The proposed project includes construction of a 402 square foot second-story addition and a 615 square foot one-story addition to an existing 2,027 square foot, one-story, single-family residence with attached garage.

The discretionary applications required for this project are:

- 1. A <u>Modification</u> to allow for alterations to the garage door and other minor improvements to the façade of the residence within the 30-foot front setback on Ricardo Avenue (SBMC §28.15.060 and §28.92.110); and
- 2. A <u>Modification</u> to allow a door to replace a window on the rear portion of the house within the 30-foot front setback on La Vista del Oceano Drive (SBMC §28.15.060 and §28.92.110).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Act Guidelines Sections 15301 (Existing Facilities) and 15305 (Minor Alterations in Land Use Limitations).

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
