RESOLUTION NO. 038-14 402 S. SALINAS STREET MODIFICATION JUNE 25, 2014

APPLICATION OF W. HOWARD WITTAUSCH ARCHITECT FOR JOHN COUDRAY, 402 SOUTH SALINAS STREET, 017-341-009, C-P LIMITED COMMERICAL ZONE, GENERAL PLAN DESIGNATION: COMMERCIAL/MEDIUM-HIGH RESIDENTIAL (15-27 DU/ACRE) (MST2014-00147)

The 5,000 square-foot corner site is developed with a 1,598 square foot commercial building with a 2,435 square foot basement, and 185 square foot storage room. The proposed project involves installation of a new electrical panel on the north side of the building, within a 20 square foot enclosure. The discretionary application required for this project is a <u>Front Setback Modification</u> to allow the panel and enclosure to encroach into the required ten-foot front setback (SBMC § 28.54.060 and SBMC § 28.92.110).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Act Guidelines Section 15301 and 15305 (Existing Facilities and Minor Alterations in Land Use Limitations).

WHEREAS, the Staff Hearing Officer has held the required public hearing on the above application, and the Applicant was present.

WHEREAS, no one appeared to speak either in favor or in opposition of the application thereto, and the following exhibits were presented for the record:

NOW, THEREFORE BE IT RESOLVED that the City Staff Hearing Officer:

- I. Approved the <u>Front Setback Modification</u> making the findings and determinations that the Modification is consistent with the purposes and intent of the zoning ordinance and is necessary to secure an appropriate improvement on the lot. The proposed enclosure is appropriate because it provides a code compliant location for electrical equipment, and the enclosure will not adversely impact the visual openness of the public street frontage.
- **II.** Said approval is subject to a condition that the applicant submit an application to Public Works for any work that is located within the public right-of-way.

This motion was passed and adopted on the 25^{th} day of June, 2014 by the Staff Hearing Officer of the City of Santa Barbara.

PLEASE BE ADVISED:

- 1. This action of the Staff Hearing Officer can be appealed to the Planning Commission or the City Council within ten (10) days after the date the action was taken by the Staff Hearing Officer.
- 2. If the scope of work exceeds the extent described in the Modification request or that which was represented to the Staff Hearing Officer at the public hearing, it may render the Staff Hearing Officer approval null and void.
- 3. If you have any existing zoning violations on the property, other than those included in the conditions above, they must be corrected within thirty (30) days of this action.
- 4. Subsequent to the outcome of any appeal action your next administrative step should be to apply for **Architectural Board of Review (ABR)** approval and then a building permit.
- 5. PLEASE NOTE: A copy of this resolution shall be reproduced on the first sheet of the drawings submitted with the application for a building permit. The location, size and design of the construction proposed in the application for the building permit shall not deviate from the location, size and design of construction approved in this modification.
- 6. NOTICE OF APPROVAL TIME LIMITS: The Staff Hearing Officer's action approving the Performance Standard Permit or Modifications shall expire two (2) years from the date of the approval, per SBMC §28.87.360, unless:
 - a. A building permit for the construction authorized by the approval is issued within twenty four months of the approval. (An extension may be granted by the Staff Hearing Officer if the construction authorized by the permit is being diligently pursued to completion.) or;
 - b. The approved use has been discontinued, abandoned or unused for a period of six months following the earlier of:
 - i. an Issuance of a Certificate of Occupancy for the use, or;
 - ii. one (1) year from granting the approval.
