Each unit would be three stories with a roof-top deck and have access to all common open yard space at the ground level. Grading for the project would comprise 140 cubic yards of excavation and 90 cubic yards of import. Access to the site is directly from Anacapa Street.

- 1. A <u>Tentative Subdivision Map</u> for a one-lot subdivision to create two (2) residential condominium units (SBMC Chapters 27.07 and 27.13); and
- 2. A <u>Coastal Development Permit</u> (CDP2012-00007) to allow the subdivision and proposed development in the Non-Appealable Jurisdiction of the City's Coastal Zone (SBMC §28.45.009).
