PROJECT DESCRIPTION: The proposed project involves the demolition of an existing non-historic garage to accommodate accessible parking and to provide additional paved parking space improvements including a new walkway, new handrails at the exterior stairs, and replacement of entry landings. The project also involves a change of use from Mixed Use to Commercial Use, with a proposed land use designation of "Business and Professional Offices." The discretionary application required for this project is: 1. Parking Modification to allow for the reduction of required parking spaces from five (5) spaces to three (3) spaces (SBMC §30.175.040 and §30.250.030) The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Act Guidelines Section 15301 (Existing Facilities) and 15305 (Minor Alterations in Land Use Limitations). **FOR MORE INFORMATION CONTACT:** Ellen Kokinda, (805) 564-5470, ext. 4559
