PROJECT DESCRIPTION: The 9,583 square-foot site is currently developed with a one-story single family dwelling with a covered front entry and an attached two-car garage. The proposed project involves a substantial redevelopment (demolition and reconstruction) of the majority of the existing building, a new roof, a first floor addition and a second-story addition including a roof deck. The project also includes site improvements including a new permeable patio in the rear yard, a rainwater cistern, rooftop solar panels, and an interior remodel. The discretionary application required for this project is:

A) A Front Setback Modification to allow for a change to the basic exterior characteristics of the residential building (SBMC §28.87.030.D.1 and SBMC §28.92.110.B). The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Act Guidelines Sections 15301 (Existing Facilities) and 15305 (Minor Alterations in Land Use Limitations). **FOR MORE INFORMATION CONTACT:** Ellen Kokinda, Assistant Planner at (805) 564-5470, ext. 4559
