PROJECT DESCRIPTION: The 40,899 square-foot site is currently developed with a single family residence with an attached two-car garage, and an existing swimming pool and spa. The proposed project includes a request to permit the “as-built” accessory pool equipment shed with skylight, a new accessory trellis, and barbeque structure, and outdoor dining and fire pit. The discretionary application under the jurisdiction of the Staff Hearing Officer required for this project is a Front Yard Modification to allow for the “as-built” accessory pool equipment shed to be located in the front yard (SBMC §30.140.090.C.7 and SBMC §30.250.060.F).
