When persons are called on to speak, their microphone will be activated and they will be notified to begin speaking. Each speaker will be given a total of 2 minutes to address the SHO. Pooling of time is not allowed during general public comment. The time allotted for general public comment at the beginning of the meeting is 30 minutes. The SHO, upon majority vote, may decline to hear a speaker on the grounds that the subject matter is beyond the SHO's subject matter jurisdiction.

Staff Hearing Officer consideration of Findings and Conditions of Approval; and 7. Action taken by the Staff Hearing Officer. \*Time may be extended or limited by the Staff Hearing Officer.

  - 1. Announcement of Staff Hearing Officer decision on a Coastal Development Permit for a project at [527 Alan Rd](#) (PLN2020-00308).

The project consists of constructing a two-story 1,121-square-foot (net) Accessory Dwelling Unit (ADU) pursuant to California Government Code §65852.2 at the rear of the property. No existing structures, trees, or significant landscaping are proposed to be removed. The subject parcel is zoned E-3/S-D-3 (One-Family Residence/Coastal Overlay) and is located in the Non-Appealable Jurisdiction of the Coastal Zone. The discretionary applications required for this project is a Coastal Development Permit (CDP2020-00019) to allow the proposed development in the Non-Appealable Jurisdiction of the City's Coastal Zone (SBMC §28.44.060).

**II. CONTINUED ITEM *CONTINUED FROM NOVEMBER 18, 2020*****APPLICATION OF SARAH BRONSTAD, APPLICANT FOR GERLAD AND SUE DEROSE, 2115 GARDEN ST, APN 025-252-004, RS-15 (SINGLE UNIT RESIDENTIAL) ZONE, GENERAL PLAN DESIGNATION: LOW DENSITY RESIDENTIAL (PLN2018-00618)**

The 14,157 square-foot site is currently developed with a 3,095 square foot residence (The Carlson House, constructed in 1927 in the Spanish Colonial Revival style by designer George Porter), a 561 square foot garage, and 496 square foot pool cabana. The proposed project involves permitting an existing unpermitted 372 square foot roof deck with access stair constructed on the second story addition of the residence.

The discretionary applications under the jurisdiction of the Staff Hearing Officer required for this project are:

- 1. Interior Setback Modification to allow for the "as-built" exterior stairs located within the 10'-0" interior setback (SBMC §30.140.140 and SBMC §30.250.030.B).
- 2. Solar Access Modification to allow relief from the Solar Access Ordinance for the "as-built" roof deck at the second story (SBMC §30.140.170 and SBMC §30.250.030.B).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Act Guidelines Section 15301 (Existing Facilities, and 15305 (Minor Alterations in Land Use Limitations).

**III. PROJECT****APPLICATION OF SCOTT COHEN, 726 E COTA ST, APN 031-231-007, C-G ZONE, GENERAL PLAN DESIGNATION: COMMERCIAL HIGH DENSITY RESIDENTIAL (MAXIMUM 28-36 DU/AC) (PLN2020-00093)**

The 4,000 square-foot site is currently developed with 904 square foot single residential unit and an approximately 120 square foot shed. The proposed project involves demolition of the shed and construction of a new 376 square foot single car garage, with a 623 square foot accessory dwelling unit above.

The discretionary applications under the jurisdiction of the Staff Hearing Officer required for this project are:

1. Interior Setback Modification to allow for to allow to allow a new garage and second-story Accessory Dwelling Unit (ADU) to be located 2 feet from the east property line instead of the required setbacks as follows: 3 feet for the garage, 6 feet for the storage room, and 4 feet for the ADU (SBMC §30.250.030);
2. Open Yard Modification to allow the stairs and garage to encroach into the open yard (SBMC §30.250.030).

The project requires an environmental finding pursuant to California Environmental Quality Act Guidelines Section 15183.
