DESIGNATED SURFACES FOR THE ABOVE NAME JOB.

EXTERIOR REPAIRS:

- 1) THE TOP OF THE 4"X 4" BLOCK-OUTS AROUND THE PERIMETER OF THE ROOF SHOULF BE SEALED WITH A MASTIC.
- 2) AREAS OF DELAMINATED CONCRETE ON THE DIGESTER ROOF SHOULD BE CHIPPED OUT TO SOUND CONCRETE CUT BACK TO AT LEAST HALF AN INCH THICK AT THE EDGES, AND PATCHED WITH A CONCRETE REPAIR MORTAR.
- 3) THE EXISTING ROOF ACCESS MANWAY SHOULD BE FLASHED TO PREVENT WATER BUILD-UP.
- 4) THE CIRCUMFERENTIAL BOLT HOLES AROUND THE MANWAY SHOULD BE CLEANED AND FILED WITH NON-SHRINK GROUT TO PREVENT WATER INFILTRATION.

INTERIOR REPAIRS:

THE REPLACEMENT OF THE INTERIOR SEAL AT THE JOINT BETWEEN THE WALLS AND ROOF.
