a. Appointment of Selection Committee Representative for the Enhanced UWMP (5 Minutes)

b. Introduction to Water Rate Development (30 Minutes)

Mr. Hamilton, Admistrative Analysis, gave an introduction to water rate development and key policy considerations, and answered questions from the Comission.

c. Annual Water Supply Management Report (20 Minutes)

Ms. Corey gave an update of the Stage One Water Supply Condition, and three-year water supply outlook. She described the findings of the Water Supply Management Report (WSMR) for Water Year 2019, finding that the groundwater resources are in long-term balance in accordance with the conjunctive management element of the City's Long-Term Water Supply Plan. Staff recommended that the Commission recommend that Council adopt the WSMR.

The Commission directed staff to move the staff recomendation.

Motion to recommend Council adoption of the Water Supply Management Report. Approved (Davis/Kielborn, 4:0:0. Keller absent.)

d. Introduction to Polyfluoroalkyl Substances (PFAS) (20 Minutes)

Given the wide spread media attention, Ms. Fair, Laboratory Superviser gave a presentation on Polyfluoroalkyl Substances (PFAS), and answered questions from the Commission. PFAS's have not been detected in the City's water supply's.

e. Water Agencies Update (CCWA/CCRB/COMB) (10 Minutes)

Mr. Haggmark provided an update on the activities of the three water agencies.

Commissioner Davis reported on the Sea-Level Rise subcommittee.

8. WATER RESOURCES MANAGER'S REPORT

Mr. Haggmark presented the Manager's Report. City Staff and Commissioners recognized Commissioner Jordan for his nearly 5 years of service during the worst drought of record and wished him all the best in his new role as councilmember
