- Rebates are available for the cost of up to two deliveries (8 -10 yards) per fiscal year (July 1 through June 30) of unscreened mulch purchased from the County of Santa Barbara. **Proof of purchase is required for all rebates.**
- A maximum of two delivery receipts may be submitted for the rebate for delivery dates within the same fiscal year (July 1 through June 30).The maximum rebate per fiscal year is \$41 for one delivery or \$82 for two deliveries.
- For City of Santa Barbara water customers only. Goleta Water District customers must apply through the Goleta program.

### STEPS TO APPLY

- Call South Coast Recycling and Transfer Station at (805) 681-4981 to schedule a mulch delivery.
- Submit a mulch [purchase agreement](#) to the County of Santa Barbara.
- Have the mulch delivered, obtain an invoice from the County of Santa Barbara and pay the County of Santa Barbara for the delivery. Save the invoice and proof of payment.
- Complete and submit this application with the invoice and proof of payment by email to: [WConservation@SantaBarbaraCA.gov](mailto:WConservation@SantaBarbaraCA.gov) or by mail to: City of Santa Barbara Water Conservation Program, PO Box 1990, Santa Barbara, CA 93102-1990. **Application materials must be postmarked within 60 days of payment.**

Once submittals are verified, rebate checks will be issued in approximately 30-60 days. Questions? Call (805) 564-5460.

### TERMS & CONDITIONS

1. Failure to comply with these terms and conditions are automatic grounds for disqualification from the program.
2. The applicant for the rebate must be the account holder or have permission from the account holder to apply for the rebate. By submitting the application the undersigned confirms that the mulch is used at the service address.
3. The service address must be have an active, non-delinquent City of Santa Barbara water service account.
4. **Only unscreened mulch from the County of Santa Barbara South Coast Recycling and Transfer Station qualifies** for the rebate.
5. The application, invoice, and proof of payment must be submitted within 60 days of the payment date. The Applicant agrees that City staff may inspect the property to verify delivery and application of the mulch at the service address before a rebate is paid.
6. The City of Santa Barbara is not responsible for items lost or destroyed in transit through the mail. Original applications will become the property of the City of Santa Barbara. Applicant must attach a legible copy of the valid, dated mulch delivery invoice and proof of payment for this application to qualify.
7. Eligibility for a rebate will be determined by City staff based on the application, proof of payment, and account verification.
8. The City of Santa Barbara is not responsible for any tax liability imposed as a result of payment of any rebates. The City of Santa Barbara does not provide tax advice and any communication by the City of Santa Barbara is not intended or written to be used, and cannot be used, for the purpose of avoiding penalties under the Internal Revenue Code.
9. Rebate amounts are subject to change without prior notice and based upon availability of funds. Rebate Terms and Conditions are subject to change without prior notice. Rebates are issued on a first come, first served basis and are subject to availability of funds. Offer void where prohibited or restricted by law.
