I am writing to express my concern about the proposed unattended hotel proposal at 928 Garden Street (PLN2023-00308).

As a neighbor in close proximity to the proposed project, I am concerned that replacing the existing office space with a hotel that will have no on-site management sets a bad precedent for the neighborhood. Since the surrounding area is a valuable historic resource for Santa Barbara, including multiple historic landmark structures, it is essential that every possible action to protect the nature and spirit of the neighborhood be taken.

Santa Barbara needs more housing for local residents, not another hotel. Residential use is a wiser and more appropriate addition to the El Caserio area. As a long time resident born and raised in Santa Barbara who now resides in El Caserio and loves this neighborhood, I would welcome new neighbors who, like me, have a long term connection to this community. Let's make it easier to convert properties such as this to residential ose to help alleviate the local housing shortage.

I've appreciated that tenants of the existing office space at 928 Garden have been considerate neighbors and have a long term connection to the community. Changing the use of the property to one that is more transient in nature could threaten the shared sense of community that characterizes the neighborhood.

Of course, I am by no means an expert on historic preservation and the role of your Commission. However, it is my sincere hope that you will agree with me and my neighbors that any changes at 928 Garden Street must be compatible and respect the concerns of those of us who steward the existing historic homes and structures in the area.

My name is Sally Terrell. I live at 321 E. Canon Perdido, and I am writing to express my concern over the project under consideration at 928 Garden Street, to convert the office space into an unattended short term rental/ hotel.

My concern is two-fold.

This project is directly adjacent to El Caserio, which is not only a unique downtown neighborhood, but has several properties that are historic landmark residences. While the building at 928 Garden is not under Historic Resource status, I believe that it's proximity is important to consider because of the immediate impact that a change of use will have on the character of this neighborhood. A keyless, short term rental/hotel does not elevate this historical area.

As a long-term owner of a Unit in El Caserio (924 Garden Street), I am interested in the longer-range prospects of our neighborhood – which inclines me to prefer residential properties – in El Pueblo Viejo Landmarks District. If the use of the property is to be redesignated to serve as a short term rental (hotel), I am concerned about the change of use from office space to hotel.

There is talk of expanding buildings into the existing parking lot area, and with no blueprints or drawings submitted we have little to go by, so that it is difficult to tell what is really going on. I am also concerned about the use as an 'unattended' short-term rental – that is courting risk. We must take care to remain compatible with existing historic (Presidio) structures.
